Larry Lapana made a motion to accept the Treasurer's Report and to pay all bills. Lou Kovach seconded the motion and the motion passed.

CORRESPONDENCE: None

OLD BUSINESS:

The Board agreed to pay Jarrett Heating for installation of the new heating and air conditioning system in the Township Building (\$16,000.00 per the bid agreement). The project is now complete.

NEW BUSINESS:

A motion was made by Larry Lapana and seconded by Lou Kovach to pay Gouker Garage Doors of Uniontown PA \$8930.00 to install new garage doors at the Township building. 50% will be paid to Gouker when the material arrives on site.

The Board also agreed to pay Swanger's Home Repair \$1470.00 for installation of new windows and \$272.00 for new overhead fluorescent lights in the Township building.

PUBLIC COMMENT:
