APPROVAL OF MINUTES: Bill Monahan made a motion to approve the minutes from the December regular meeting. Lou Kovach seconded the motion and the motion passed unanimously.

OLD BUSINESS:
The Supervisors are continuing to review the Township's Floodplain Maps. Maps are available for the public to review at the Township Building by appointment.

NEW BUSINESS AND PUBLIC COMMENT:

Trudi Monahan reported that Senior Day was held on December 20, 2018. Senior Life gave a presentation on their services, provided games and prizes, and presented a cookie tray. Amedisys did their monthly blood pressure screenings. The next Senior Day will be on January 17, 2019. A rental of the building has been scheduled for January 26. \$45.00 was collected in donations.
