The supervisors contacted the Greene County Redevelopment Authority about help with several blighted properties in the township. Joe Kovach made a motion to authorize Kevin O'Malley and Brian Lake (K2

Engineering) to report on the possibility of these properties qualifying for the County's blighted property program. Bill Monahan seconded the motion, and the motion passed unanimously.
